LNC ES Plan A – Four Days Per Week/No Cohorts

- Least restrictive of all the 3 State plans.
- All students (except distance learners) attend in-person school 4 days a week with abbreviated school hours.
- In-person school days are Monday, Tuesday, Thursday, Friday
- School hours are 8:30AM-2:30PM
- Wednesday is a student seminar day
- All health and safety protocols followed, as outlined in our [Health & Safety Protocols](#) EXCEPT social distancing of 6' at all times is not required.
- All students and staff required to wear a facial covering/mask that covers their nose and mouth while indoors. Please note that face shields are not a substitute for masks.
- Efforts made to social distance in classroom as much as possible. Where needed, Plexiglas dividers will be provided at tables in between students to minimize exposure.
- No large group assemblies.
- Students kept within their same classroom group to limit exposure with those students transitioning together for activities outside of classroom, i.e., restrooms, recess and specials.
- All K-4 classes have one teacher for all subject areas.
- Classrooms contain designated “teacher-only” areas to allow for social distancing between the teacher and students as much as possible.
- One-way hallways implemented to minimize face-to-face encounters.
- Lunches eaten in the classroom. Peanut-free classes have been predetermined for each grade level to ensure student health and safety.
- Classrooms will be cleaned throughout the day and in particular after all lunches.
- Designated PTO members deliver catered lunches utilizing all protocols.
- Volunteering limited to only essential needs, following all health and safety protocols.
- Students bring their own water bottles as water fountains will be closed, bottle-filling stations open.
- Teachers teach and reinforce healthy hygiene habits ensuring extra handwashing is practiced throughout the day.
- Scheduled restroom breaks will be provided during the school day for students 1st – 4th. (Kindergarten students have restrooms in their classrooms).

- If a student has an emergency and needs to use the restroom during an unscheduled break, they will be required to wash their hands again upon returning to the classroom.
- K-4 students will attend specials for 45 minutes (instead of the traditional 60, ensuring adequate time to disinfect and sanitize any materials and all surfaces in preparation for the next class.
- Specials will be held in a “cohort style,” whereby a class will attend a single special for 3 weeks at a time before rotating to the next special. K-4 classes will be separated at recess, playing in 6 predetermined locations outside.
- Parents will complete the attestation form and students will have their temperature checked each morning.
- Students must bring their own school supplies to use in their class. Parents should label all supplies with their child’s name before bringing to school.
